The discussion will also include impacts of some biotic and abiotic factors that impact plant growth and development. Practical application of this knowledge will involve combining the basic and applied aspects of herbicide mode of action knowledge to direct vegetation applications relative to application timing, application methods, and environmental factors, as well as understanding POST treatment assessment and investigations involving performance.
